

Camp Nubar 2021 Summer Guidelines

To Our Camp Nubar Family,

As we prepare to reopen this summer, we ask that you carefully review the guidelines below. We will need the full support and cooperation of all parents, staff, and campers to ensure a safe and happy 2021 season. If we all work together, we can ensure a safe and fun summer for our campers. We appreciate your cooperation and support through these unprecedented times, and look forward to a wonderful 2021 season!

Please note, we will be closely monitoring the guidelines as released by the CDC & NYS DOH and revising the below on an as needed basis

Camp Schedule & Enrollment



- **2021 Summer Session:**
 - Saturday, July 3 - Saturday, July 31st
 - Campers must arrive and depart on these dates, without exception
 - This year we are offering one, four-week session to ensure a seamless and safe experience
 - There will be no Open House or Visiting Days
- **Enrollment:**
 - Limited by age group
 - Total capacity subject to change in accordance with CDC and NY State DOH guidelines & regulations
- **Tuition:**
 - 2021 Deposit will be non-refundable
 - Additional \$200 COVID-Safety Fee* will be charged per camper
- **Required Emergency Contacts:**
 - All campers must have **two** emergency contacts
 - Each contact must be within driving distance of camp
 - Each contact must confirm in writing that they will be able to pick up their camper at any time



Camper Arrival & Departure

- All campers must arrive by car
- Camper arrival & departure times will be assigned to families
- Only campers will be allowed beyond the front gate
- Any campers travelling from out of region must comply with NYS quarantine rules in effect at the time



Medical Protocol

- **Pre-Camp COVID Testing:**
 - All campers & counselors will be required to provide proof of a negative PCR test within 72 hours prior to their arrival at camp
 - Campers and counselors will be expected to self-isolate from the time of their test until their arrival
- **Camp Arrival Testing Protocol:**
 - All campers & counselors will receive an additional test 48 hours after their arrival at camp
- **Daily Health Monitoring:**
 - All campers & counselors will undergo a daily health screening
- **Suspected Case Protocol:**
 - Any camper or staff member who has COVID symptoms will be isolated pending results of a COVID test
 - Any camper or staff member who test positive for COVID will be required to leave camp immediately
 - Close contacts of a COVID-positive camper or staff member will be isolated and tested



Daily Camp Operations

- **Overarching Protocol:**
 - Mask & social distancing policies will be developed based on NY state guidelines at the time camp begins
 - Campers will be provided with disposable masks

- Campers & counselors will be expected to remain on camp grounds at all times
- **Cabins:**
 - Bunks & cubbies will be pre-assigned prior to camper arrival (campers will receive assistance getting settled as needed) - bedding should be packed separately so it can be unpacked promptly
 - Cabins will act as initial cohorts for activities with expansion within age ranges for larger group activities or as deemed appropriately by camp leadership and CDC guidelines.
- **Activities:**
 - Campers will be assigned an activity schedule with their cabins upon arrival
 - Horseback riding will not be offered
 - All activities with shared equipment will be sanitized between classes
- **Meals:**
 - Meals will take place in shifts and outdoors (weather permitting)
- **Other:**
 - Evening Activities will take place outdoors or in the Pavilion as much as possible
 - Campers will be allowed to receive food-free packages this summer, per updated guidance from the CDC

**Additional fee for 2021 included to cover costs of sanitizing equipment, PPE, regular covid tests, additional medical staff and other safety measures. We have done our best to mitigate costs while keeping our campers, staff, and facilities as safe as possible*
